ORIGINAL PARCEL:

Commencing at the Northwest corner of the NW 1/4, Section 29, thence South along the West line of said NW 1/4 559.00 feet for the point of beginning; thence with a deflection angle 90 degrees 00 minutes 00 seconds left-East 431.00 feet; thence with a deflection angle 90 degrees 00 minutes 00 seconds right-South parallel with the West line of said NW 1/4 391.00 feet; thence with a deflection 90 degrees 00 minutes 00 seconds right—West 431.00 feet to the West line of said NW 1/4; thence with a deflection angle 90 degrees 00 minutes 00 seconds right—North along the West line of said NW ¼ 391.00 feet to the point of beginning, McPherson


