


CHEROKEE ROAD

Commencing at the Southeast corner of said Northeast Quarter; thence on a NAD 83 Kansas South Zone bearing of South 89°39'35" West on the South line of said Northeast Quarter a distance of 1103.32 feet to the point of beginning; thence continuing South 89°39'35" West on said South line a distance of 886.87 feet to a point being 660.00 feet (Record) West of the Southeast corner of the Southwest Quarter of said Northeast Quarter; thence North 00°20'34" West parallel with the East line of said Southwest Quarter of the Northeast Quarter a distance of 1877.17 feet (1864.50 Record) to a point 775.50 feet South of the North line of said Northeast Quarter; thence North 89°42'26" East parallel with said North line a distance of 660.00 feet (Record) to the East line of the Northwest Quarter of said Northeast Quarter; thence South 00°20'34" East on said East line a distance of 550.56 feet to the Southeast corner of said Northwest Quarter of the Northeast Quarter; thence North 89°41'00" East on the North line of the Southeast Quarter of said Northeast Quarter a distance of 191.39 feet; thence South 01°52'32"
