## Report of Survey

Research of the records at the McPherson County Public Works Department and McPherson County Court House revealed the following information:

Roads: Cheyenne Road is 66 feet wide, 33 feet on each side of section line. 21st Avenue is 66 feet wide, 33 feet on each side of section line. The 33 foot R/W area on the west side of the 14.1 acre parcel contains 0.2 acre. The 33 foot R/W area on the south side of 10.0 acre parcel contains 0.6 acre.

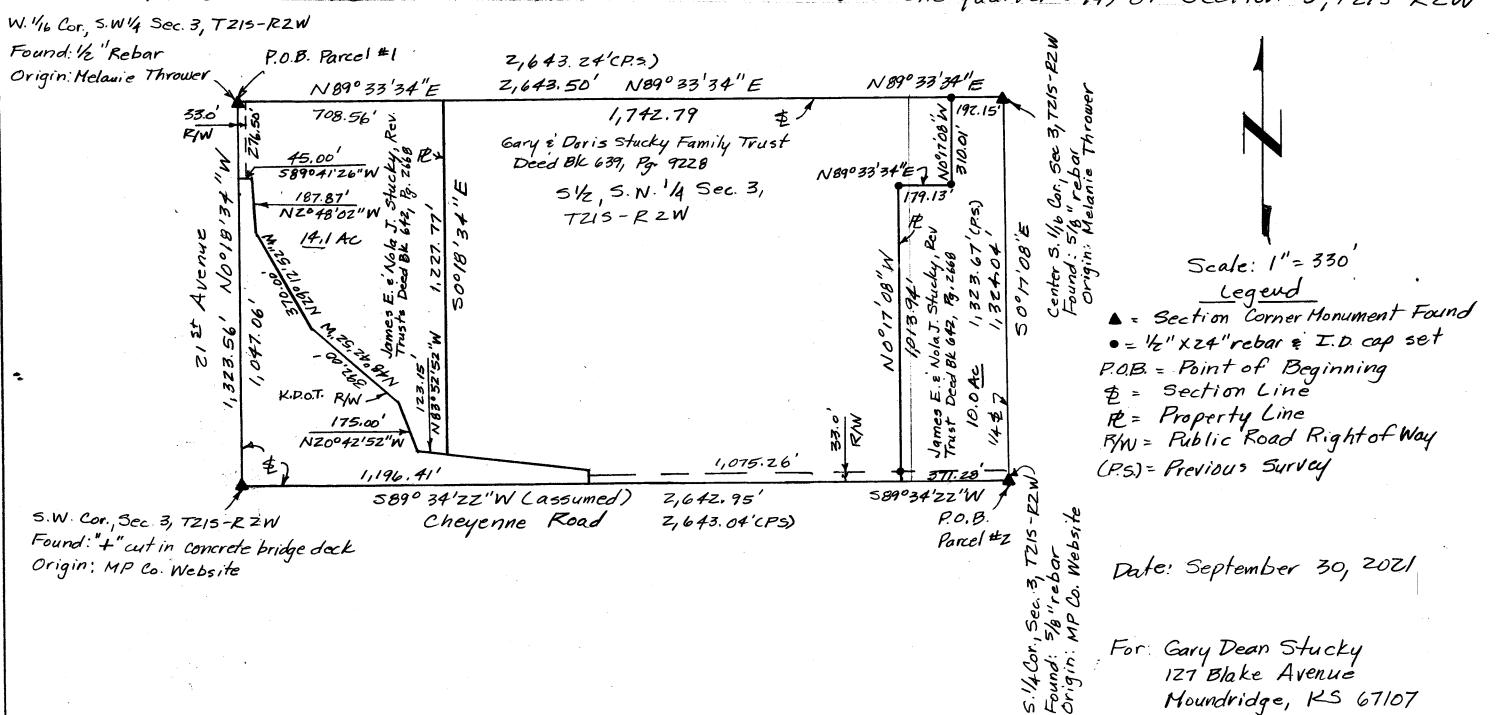
<u>Surveys:</u> The Original General Land Office Township Lines run by James Withrow in November 1860. Original General Land Office Subdivisions completed by Abraham Ray, completed November, 4 thru 9, 1861. Survey in Section 3, T20S-R2W by Melanie L. Thrower, dated 10-24-2004. Section corner references found at the McPherson County Public Works vault.

<u>Field Procedure:</u> G.P.S. positions were observed with GR3 Topcon G.P.S. receivers. Distances and angles read with a Nikon DTM 522 Total Station. All distances are calculated/measured distances. I set 1/2" x 24 " rebars at the property pins monumented.
