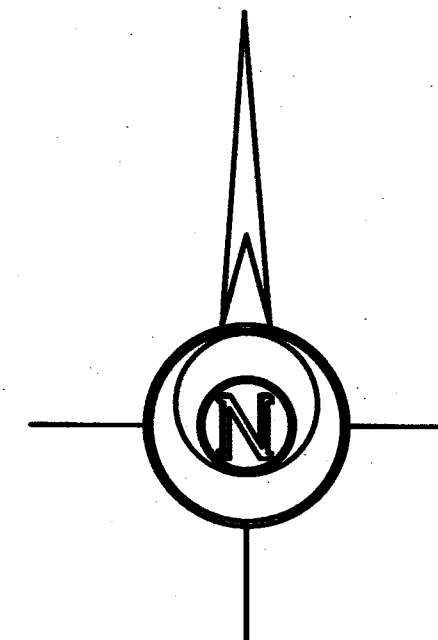

Beginning at the Northeast corner of said Southeast Quarter; thence on a NAD 83 Kansas South Zone bearing of South 00°28'02" East on the East line of said Southeast Quarter a distance of 724.67 feet; thence South 89°28'09" West a distance of 1325.61 feet; thence North 00°43'22" East a distance of 724.67 feet to the North line of said Southeast Quarter; thence North 89°27'42" East on said North line a distance of 1310.56 feet to the point of beginning.

Containing 21.93 Acres and subject to a road right of way easement along the East line thereof and any other easements or restrictions of record.

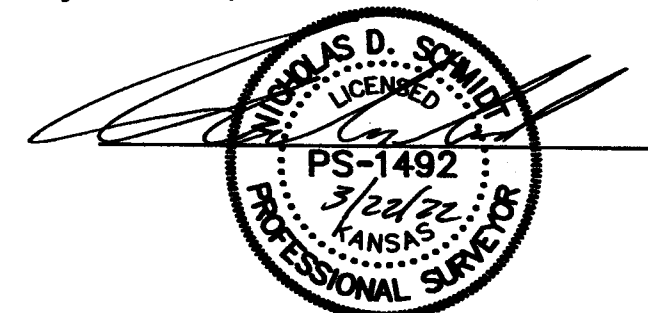
