PARCEL 1

Portions of the Northeast and Northwest Quarters of Section 5, Township 21 South, Range 2 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Beginning at the Northwest corner of the Northwest Quarter of Section 5, Township 21 South, Range 2 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 bearing North 89°24'13" East along the North line of said Northwest Quarter 2654.15 feet to the Northeast corner of said Northwest Quarter; thence North 89°24'13" East along the North line of the Northeast Quarter of said Section 5 a distance of 445.50 feet (Record); thence South 14°27'43" West 919.26 feet (900.9 feet Record); thence South 89°24'13" West parallel with the North line of said Northeast Quarter 209.55 feet (Record) to the West line of said Northeast Quarter; thence North 00°24'38" West along said West line 280.57 feet; thence South 89°24'13" West parallel with the North line of said Northwest Quarter 2655.22 feet to the West line of said Northwest Quarter; thence North 00°18'36" West along said West line 607.13 feet to the point of beginning, containing **43.675 Acres**, subject to road right of way easements across the West and North 33.00 feet thereof, and any other easements or restrictions of record.

PARCEL 2

A portion of Northwest Quarter of Section 5, Township 21 South, Range 2 West of the 6th Principal Meridian, McPherson County, Kansas described as follows:

Commencing at the Northwest corner of the Northwest Quarter of Section 5, Township 21 South, Range 2 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 bearing South 00°18'36" East along the West line of said Northwest Quarter 607.13 feet to the point of beginning; thence North 89°24'13" East parallel with the North line of said Northwest Quarter 2655.22 feet to the East line of said Northwest Quarter; thence South 00°24'38" East along said East line 705.28 feet; thence South 89°24'14" West 2656.45 feet to the West line of said Northwest Quarter; thence North 00°18'36" West along said West line 705.28 feet to the point of beginning, containing **43.000 Acres**, subject to a road right of way easement across the West 33.00 feet thereof, and any other easements or restrictions of record.


PARCEL 3

Commencing at the Northwest corner of the Northwest Quarter of Section 5, Township 21 South, Range 2 West of the 6th Principal Meridian; thence on a Kansas State Plane Zone 1502 bearing South 0018'36" East along the West line of said Northwest Quarter 1312.41 feet to the point of beginning; thence Northeast 89°24'14" East parallel with the North line of said Northwest Quarter 2656.45 feet to the East line of said Northwest Quarter; thence South 00°24'38" East along said East line 1118.80 feet to the Southeast corner of said Northwest Quarter; thence South 89°58'12" West along the South line of said Northwest Quarter 66.00 feet (Record); thence South 43°05'04" West 791.09 feet (792.0 feet Record); thence North 89°58'12" East parallel with the North line of the Southwest Quarter of said Section 5 a distance of 610.50 feet (Record) to the East line of said Southwest Quarter; thence South 00°24'35" East along said East line 12.29 feet; thence South 89°58'12" West parallel with the North line of said Southwest Quarter 1329.71 feet to the West line of the East Half of said Southwest Quarter; thence South 00°21'37" East along said West line of the East Half of the Southwest Quarter 65.51 feet; thence South 89°58'12" West parallel with the North line of said Southwest Quarter 1329.77 feet to the West line of said Southwest Quarter; thence North 00°18'41" West along the West line of said Southwest Quarter 655.30 feet to the Northwest Corner of said Southwest Quarter: thence North 0018'36" West along the West line of said Northwest Quarter 1092.53 feet to the point of beginning, containing 100.967 Acres, subject to a road right of way easement across the West 33.00 feet thereof, and any other easements or restrictions of
