BEGINNING IN THE SOUTHWEST CORNER OF THE E 1/2 SE 1/4 OF SAID SECTION 23, THENCE 295 FEET NORTH, THENCE 295 FEET EAST, THENCE 295 FEET SOUTH, THENCE 295 WEST TO THE POINT OF BEGINNING;

AND EXCEPT A TRACT OF LAND DESCRIBED AS FOLLOWS:

BEGINNING IN THE SOUTHEAST CORNER OF THE E 1/2 SE 1/4 OF SAID SECTION 23, THENCE 295 FEET NORTH, THENCE 295 FEET WEST, THENCE 295 FEET SOUTH, THENCE 295 FEET EAST TO THE POINT OF BEGINNING; AND EXCEPT A TRACT OF LAND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF THE SE 1/4 OF SAID SECTION 23; THENCE WITH AN ASSUMED BEARING OF NORTH OO DEGREES OO MINUTES OO SECONDS EAST ALONG THE EAST LINE OF SAID SE 1/4 1118.37 FEET FOR THE POINT OF BEGINNING; THENCE SOUTH 87 DEGREES 59 MINUTES 12 SECONDS WEST 651.05 FEET; THENCE NORTH 00 DEGREES 33' MINUTES 49 SECONDS EAST 675.00 FEET; THENCE NORTH 56 DEGREES 18 MINUTES 09 SECONDS EAST 774.07 FEET TO THE EAST LINE OF SAID SE 1/4; THENCE SOUTH 00 DEGREES 00 MINUTES 00 SECONDS EAST ALONG THE EAST LINE OF SAID SE 1/4 1081.55 FEET TO THE POINT OF BEGINNING, MCPHERSON COUNTY, KANSAS.
