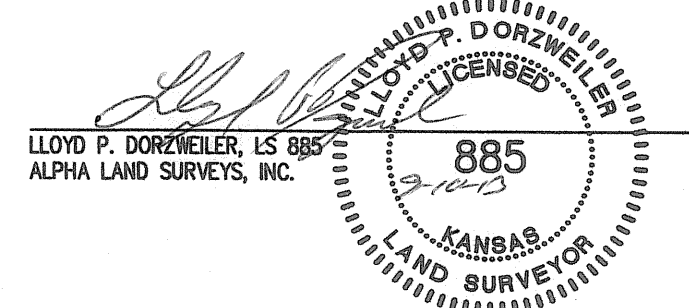


DESCRIPTION:
A PORTION OF THE NORTHEAST QUARTER OF SECTION 30, TOWNSHIP 21 SOUTH, RANGE 3 WEST OF THE 6TH PRINCIPAL MERIDIAN, MCPHERSON COUNTY, KANSAS DESCRIBED AS FOLLOWS:
COMMENCING AT THE NORTHEAST CORNER OF SAID NORTHEAST QUARTER; THENCE SOUTH 00°26'02" EAST (BASIS OF BEARING IS NAD83 GRID KANSAS SOUTH ZONE) ALONG THE EAST LINE OF SAID NORTHEAST QUARTER 447.83 FEET FOR THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 00°26'02" EAST ALONG THE EAST LINE OF SAID NORTHEAST QUARTER 359.84 FEET; THENCE SOUTH 89°52'22" WEST 358.88 FEET; THENCE NORTH 59°39'30" WEST 117.99 FEET; THENCE NORTH 38°29'21" WEST 61.80 FEET; THENCE NORTH 00°26'02" WEST 212.27 FEET; THENCE NORTH 45°11'57" EAST 35.46 FEET; THENCE NORTH 88°14'35" EAST 474.00 FEET TO THE POINT OF BEGINNING, CONTAINING 3.885 ACRES, SUBJECT TO A ROAD RIGHT-OF-WAY EASEMENT ACROSS THE EAST 33.00 FEET THEREOF AND ANY OTHER EASEMENTS OF RECORD.

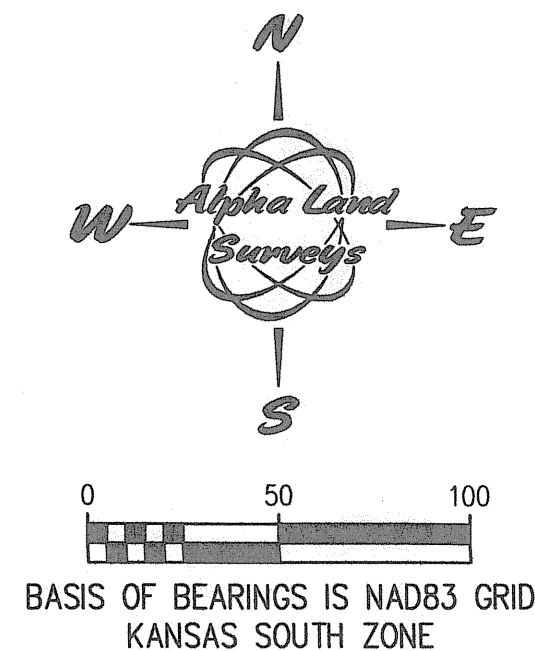
