**Report of Survey** 

Research of the records at the McPherson County Public Works Department and McPherson County Court House revealed the following information:

Roads: 13th Avenue is 66 feet wide, 33 feet on each side of section line. Apache Road is 33 feet wide on the north side of the section line.

Surveys: Original General Land Office township exteriors by James Withrow, completed September 1860 and Township Subdivisions By Stuck and Hill, dated November 1-3, 1860. Boundary survey by Garber, dated 7-31-2013. Section corner references found at the McPherson County Public Works vault.

Field Procedure: G.P.S. positions were observed with Ashtech Static G.P.S. receivers. Distances and angles read with a Nikon DTM 522 Total Station. All distances are calculated/measured distances. I set 1/2" x 24 " rebars at the property pins monumented.
