Report of Survey

Research of the records of McPherson County Courthouse and Public Works Office revealed the following information:

<u>Surveys:</u> G.L.O. subdivisions by Stuck and Hill, dated November 4-7, 1860. Township lines by James Withrow, dated September 1860. Boundary Survey by Ovid Woods, dated September 16, 2001. Surveys and section corner references found at the McPherson County Public Works Department Records Vault.

<u>Road origins:</u> 7th Avenue is 33 feet on each side of the section line. Cherokee Road and K-61 Highway varies, these parcels affected by K-61 Highway right of way only. K-61 Highway project 61-59 K-8253-01, dated 2008.

<u>Field procedure:</u> Static G.P.S. observation performed with Ashtech Static Receivers. Distances and angles read with a DTM 521 Nikon Total Station.
