Report of Survey

Roads: County road on the west side of railroad right of way in section 31, T17S-R3W, 33.0 feet wide, runs parallel to the W. right of way line of the existing railroad right of way to the section line between the W. 1/4 corner of section 32 and the E. 1/4 corner of section 32, thence east along the N. side of the said section line between the W. 1/4 and E. 1/4 corners of section 32, 33.0 feet on the north side of the said line. This R/W width was established by a petition filed July 8, 1902 and surveyed by H.A. Rowland in December of 1902. Union Pacific railroad strip map, drawing #35252, dated March 17, 1917.
