Report of Survey

Research of the records at the McPherson County Public works office revealed the following information:

Roads: Plum Avenue contains 33.00 feet of road right of way on the East side of Section Line. This parcel contains 0.02 acre of road right of way. This road right of way originates with a statute passed in 1872 by the Kansas State Legislature and ratified by the board of county commissioners that same year.
