Commencing at the Southwest Corner of the Southwest Quarter of Section 14, Township 19 South, Range 3 West of the 6th Principal Meridian; thence with an assumed bearing of North 89°36'20" East along the South line of said Southwest Quarter 644.00 feet; thence departing said line bearing North 00°26'46" West parallel with the West line of said Southwest Quarter 361.50 feet for a point of beginning; thence continuing North 00°26'46" West parallel with the West line of said Southwest Quarter 440.00 feet; thence North 89°55'29" East parallel with the North line of said Southwest Quarter 73.28 feet; thence North 00°26'46" West parallel with the West line of said Southwest Quarter 1552.02 feet; thence North 89'55'29" East parallel with the North line of said Southwest Quarter 106.72 feet; thence North 00°26'46" West parallel with the West line of said Southwest Quarter 300.00 feet to the North line of said Southwest Quarter; thence North 89°55'29" East along the North line of said Southwest Quarter 787.00 feet; thence departing said line bearing South 00°26'46" East parallel with the West line of said Southwest Quarter 2578.73 feet to the Right-of-way of I-135 Highway; thence South 85'49'20" West along the Right-of-way of I-135 Highway 143.52 feet; thence South 69°58'17" West continuing along the Right-of-way of I-135 Highway 104.58 feet; thence South 00°36'20" West 24.80 feet to the South line of said Southwest Quarter; thence South 89°36'20" West along the South line of said Southwest Quarter 409.25 feet; thence departing said line bearing North 00°23'21" West 361.50 feet; thence South 89°36'20" West parallel with the South line of said Southwest Quarter 315.89 feet to the point of beginning containing 52.067 Acres, subject to a road Right-of-way across the South 33.00 feet thereof and any other easements of record.



Commencing at the Southwest Corner of the Southwest Quarter of Section 14, Township 19 South, Range 3 West of the 6th Principal Meridian; thence with an assumed bearing of North 89°36'20" East along the South line of said Southwest Quarter 1611.00 feet; thence departing said line bearing North 00°26'46" West parallel with the West line of said Southwest Quarter 69.41 feet to the Right—of—way of I—135 Highway for a point of beginning; thence departing said Right—of—way continuing North 00°26'46" West parallel with the West line of said Southwest Quarter 2578.73 feet to the North line of said Southwest Quarter; thence North 89°55'29" East along the North line of said Southwest Quarter 919.91 feet to the Western Right—of—way of I—135 Highway; thence departing said line bearing South 00°09'45" East along the Western Right—of—way of I—135 Highway 2513.09 feet; thence South 85°47'20" West along the Right—of—way of I—135 Highway 908.10 feet; thence South 85°49'20" West along the Right—of—way of I—135 Highway 1.28 feet to the point of beginning containing 53.395 Acres, subject to any easements of record.
