

DESCRIPTION: PARCEL 1

BASIS OF BEARING = ASSUMED

A portion of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as follows:

Beginning at the Southwest Corner of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian; thence with an assumed bearing of North 01°07'00" West along the West line of said Southwest Quarter 768.27 feet; thence departing said line bearing North 90°00'00" East parallel with the South line of said Southwest Quarter 2654.73 feet to the East line of said Southwest Quarter; thence South 00°58'38" East along the East line of said Southwest Quarter 261.26 feet to a point that is 506.98 feet North of the Southeast Corner of said Southwest Quarter; thence departing said line bearing North 00°00'00" West parallel with the South line of said Southwest Quarter 616.97 feet; thence South 01°07'00" East parallel with the West line of said Southwest Quarter 263.26 feet; thence North 90°00'00" East parallel with the South line of said Southwest Quarter 67.29 feet; thence South 01°07'00" East parallel with the West line of said Southwest Quarter 243.74 feet to the South line of said Southwest Quarter; thence North 90°00'00" West along the South line of said Southwest Quarter 2104.43 feet to the point of beginning containing 40.00 Acres, subject to road right-of-way easements across the South and West 33.00 feet thereof and any other easements of record.


PARCEL 2

A portion of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian, McPherson County, Kansas more particularly described as

Beginning at the Southeast Corner of the Southwest Quarter of Section 16, Township 20 South, Range 1 West of the 6th Principal Meridian; thence with an assumed bearing of thence North 90°00'00" West along the South line of said Southwest Quarter 548.45 feet; thence departing said line bearing North 01°07'00" West parallel with the West line of said Southwest Quarter 243.74 feet; thence North 90°00'00" West parallel with the South line of said Southwest Quarter 67.29 feet; thence North 01°07'00" West parallel with the West line of said Southwest Quarter 263.26 feet; thence North 90°00'00" East parallel with the South line of said Southwest Quarter 616.97 feet to the East line of said Southwest Quarter; thence South 00'58'38" East along the East line of said Southwest Quarter 506.98 feet to the point of beginning containing 6.796 Acres, subject to a road right-of-way easement across the South 33.00 feet thereof and any other easements of record.
