COMMENCING AT THE SOUTHEAST CORNER OF SAID SOUTHWEST QUARTER; THENCE SOUTH 89°38'45" WEST (BASIS OF BEARING IS NAD83 GRID KANSAS SOUTH ZONE) ALONG THE SOUTH LINE SAID SOUTHWEST QUARTER 1335.18 FEET FOR THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 89°38'45" WEST ALONG THE SOUTH LINE OF SAID SOUTHWEST QUARTER 404.82 FEET; THENCE NORTH 00°42'44" WEST 485.53 FEET; THENCE NORTH 85°51'59" EAST 406.14 FEET; THENCE SOUTH 00°38'40" EAST 512.30 FEET TO THE POINT OF BEGINNING, CONTAINING 4.640 ACRES, SUBJECT TO A ROAD RIGHT-OF-WAY EASEMENT ACROSS THE SOUTH 33.00 FEET AND ANY OTHER EASEMENTS OF RECORD.




